Document Bill of Lading (Commercial Document)
Document Category Universal Document

Notes This document can be used if no country-specific requirements already exist. A bill of lading is a negotiable instrument which means it is a document of title and the title of the goods can be transferred using this document. Different bills of lading exist, depending on the method of transport.

Document Commercial Invoice (Commercial Document)

Notes This document can be used if no country-specific requirements already exist. A commercial invoice is a formal demand note for payment, issued by the exporter to the importer for goods sold under a sales contract. The document gives details of the goods sold, payment terms and trade terms. In addition, it is used for the customs clearance of goods and serves as a base for calculating customs duties.

Document Confirmation of Insurance (Commercial Document)

Notes This document can be used if no country-specific requirements already exist. A confirmation of insurance is a document issued by an insurance company. It confirms that an insurance policy has been purchased. It covers the loss or damage of ships, cargo, terminals, and any transport or cargo by which property is transferred, acquired, or held between the points of origin and final destination. The terms and conditions covered are as per the insurance documents.

Document Packing List (Commercial Document)

Notes This document can be used if no country-specific requirements already exist. A packing list provides details about the shipment such as number of packages, weight, volume and description of the merchandise. One objective of the packing list is to facilitate the inspection and survey of the consignment that comprises the shipment and is included in the invoice. Custom officials and carriers use the packing list as a check-list to verify the outgoing and incoming cargo.

Document Proforma Invoice (Commercial Document)

Notes This document can be used if no country-specific requirements already exist. A proforma invoice is a price quote or estimated invoice sent by a seller to a buyer in advance of a delivery of goods. It informs the buyer of the kind and quantity of goods, their value, and other important information such as weight and payment terms. This helps the buyer to make a transaction decision and to confirm the order.

Document Sea Waybill (Commercial Document)

Responsible Party Importer,Carrier
Notes This document can be used if no country-specific requirements already exist. A waybill is a document providing for the automatic release of cargo to a named consignee. It is a receipt of goods but not a negotiable instrument and is an evidence of contract of carriage. The use of waybill does not effect the terms of the carriage and the terms of carriage may differ as per the carriers policies.

Notes The documents containing the particulars demanded by the customs with respect to contents, weight and measurements for cargo coming through the sea route. One original copy is required.

Notes A document which lists all bills of lading particulars of the goods loaded on an airplane, for official and administrative purposes. One original copy is required. Submission procedure - Complete the following documents and submit them to the enforcement section of the Customs office having jurisdiction over the location of a Customs airport you are arriving. Note that documents to be attached may be submitted via fax but their originals must be presented later. Moreover, cargo information must be reported not later than 3 hours prior to the arrival of the aircraft at a Customs airport. Crew and passenger information must be reported not later than 90 minutes prior to the arrival at a Customs airport. This timeframe may differ depending on the flight length between the last airport of departure and the intended airport of arrival, Please consult with Customs in advance.

Notes The certificate shall fulfill the following conditions: (1) It shall be made out by a reliable authority or agency duly authorized for that purpose by the country of issue. (2) It shall contain all the particulars necessary for identifying the product to which it relates, in particular: The number of packages, their nature, and the marks and numbers they

bear; the type of product, the gross and net weight of the product; the name of the consignor. (3) It shall certify unambiguously that the product to which it relates originated in a specific country. Certificate of Origin is required only on goods granted duty concessions by Japan under the World Trade Organization or Generalized System of Preferences (GSP Form A). Two original copies in general should accompany other documents.

Notes Importer
 All imports require the importer or their authorized agent to submit Import Declaration form to Customs. It is a customs duty payment form describing necessary particulars to the Customs. It must be accompanied by Invoice, Bill of lading (or Air Way Bill), Insurance certificate, Freight account and Packing list. Three copies either in Japanese or English are required. Once the import declaration has been accepted by Customs, it cannot be altered without special approval of the Customs.
